BE IT FURTHER RESOLVED to acknowledge that the 2010/2011 school budget as described above includes a \$162,000 withdrawal from the capital reserve account.

BE IT FURTHER RESOLVED to acknowledge that the 2010/2011 school budget as described above results in a general fund tax levy of \$3,578,435. and a debt service tax levy of \$402,990.
